

The bidders shall upload scanned copy of Bid Security on **EPADS**. Original Bid Security must be submitted to the Procuring Agency on or before the closing date & time of e-bids submission, failing which the e-bid shall be rejected.
4. The bidders must quote firm and final prices and no request for escalation in cost after the bid opening shall be entertained.
5. Open Competitive Bidding as per PPRA Rule 36(b) Single Stage Two Envelope procedure shall be followed.
