

- 3- All e-bids must be accompanied by Bid Security amount mentioned in bidding document in the favour of Chief Executive Officer HESCO, Hyderabad in the shape of "Bank Guarantee" / CDR / Banker Cheque from any scheduled Bank of Pakistan, valid for 28-days beyond bid validity date. The bidders shall upload scanned copy of Bid Security on EPADS. Original Bid Security must be submitted to the Procuring Agency on or before the closing date & time of e-bids submission, failing which the e-bid shall be rejected.
- 4- The bidders must quote firm and final prices and no request for escalation in cost after the bid opening shall be entertained.
