# MINUTES OF 111TH BOD MEETING HESCO HYDERABAD

Meeting of 111<sup>th</sup> BOD HESCO was held on Wednesday, the 23<sup>rd</sup> September, 2015 at 11:00 am in the Committee Room, HESCO Power Wing Colony Hussainabad, Hyderabad. Following participated in the meeting:

Company Secretary warmly welcomed the newly nominated Directors of BOD HESCO and thereafter the meeting commenced with the recitation from the Holy Qura'an by Mr. Nazar Hussain Mahar. Afterwards, Directors of BOD HESCO introduced themselves and Company Secretary presented following agenda points one by one according to the working paper.

## Agenda-1 INTRODUCTION OF NEW DIRECTORS OF BOD HESCO

The Company Secretary informed that the Ministry of Water & Power GoP, Islamabad vide letter No.6(25)2012-BOD HESCO dated 22<sup>nd</sup> September, 2015 has conveyed the approval of Honourable Prime Minister of Pakistan for re-constitution of HESCO Board of Directors with following composition:

CHAIRMAN BOD HESCO, Hydersbad,

The Company Secretary further informed that as per Corporate Governance Rules, 2013 Section 4(4) "The Board shall elect its Chairman from amongst the Independent Directors so as to achieve an appropriate balance of power, increasing accountability and improving the Board's capacity for exercising independent judgment." Therefore, he requested the Honourable Directors of BOD to Appoint / Elect Chairman BOD HESCO and to welcome Mr. Akhtar Ali Randhawa, Chief Executive Officer HESCO to work in the capacity of Director BOD HESCO in the best interest of company. He informed the Board that Mr. Mehmood Nawaz Shah is out of Country whereas Mr. Shafique Ahmed Mahesar, Commissioner Mirpurkhas is preoccupied on other assignment.

### APPOINTMENT / ELECTION OF CHAIRMAN BOD HESCO

Prof. Dr. Muhammad Aslam Uqaili proposed the name of Mr. Nazar Hussain Mahar for the Chairmanship of BOD HESCO, which was seconded by Syed Asif Hyder Shah, Mr. Mehfooz Ahmed Bhatti, Mr. Tassuduq Hussain, Mr. Waqas Anwar Qureshi & Mr. Akhtar Ali Randhawa. Mr. Mehfooz Ahmed Bhatti also informed that Mr. Shafique Ahmed Mahesser who could not attend the meeting but has conveyed his message on phone that he proposes Mr. Nazar Hussain Mahar as Chairman. Consequently, Mr. Nazar Hussain Mahar became the new Chairman of BOD HESCO.

Mr. Nazar Hussain Mahar, newly elected Chairman BOD in his opening remarks thanks His Excellency Prime Minister of Pakistan, Ministry of Water & Power as well as all Directors of BOD HESCO for reposing confidence over him. He further expressed that he feels that it is great challenge for BOD team to improve the progress of HESCO and assured that he alongwith his team will support in all respect to improve overall performance of HESCO and make a difference. Chairman BOD further stressed that by the grace of Almighty ALLAH we have a very competent team in HESCO Board, although Mr. Akhtar Ali Randhawa is a new CEO for this Company but he wants to deliver. All Honorable Board Directors furthers shared their precious view points and ensured their maximum support not only personally but as well as professionally.

Prof. Dr. Muhammad Aslam Uqaili informed that he is basically an "Electrical Engineer" and now a days working as Vice Chancellor of Mehran University of Engineering. He endorsed his full support to Board and CEO HESCO technically or professionally for improvement of Company.
