## Agenda # 3 REGULARIZATION OF DAILY WAGERS

#### **POINTS OF DISCUSSION:**

The matter was considered and discussed in detail by all the Honorable members of HR Committee. Deputy Manager (L&L) Mr. Ali Khan Jamali also attended the meeting to brief the court decision to the Honorable Members of HR Committee.

Following are the note able points discussed in the meeting: -

- Deputy Director (L&L) apprised that as per orders of Honorable Sindh High Court Hyderabad, compliance within 15 days is mandatory.
- 2. DG(HR) apprised that the requisite documents required in the previous 50<sup>th</sup> HR Committee meeting have been annexed with the agenda. He also confirmed that there is no bar on regularization of these Daily Wagers from any corner and all these Daily Wagers are eligible for regularization against the sanctioned posts they are working subject to scrutiny of pre-requisites by the Regularization/Selection committees.
- 3.DG HR also informed that all cases pending in NAB & FIA Courts against the concerned officers of HESCO have been finalized and they all have been Acquitted of the charges due to non-availably of sufficient poof and giving benefit of doubt.
- 4. Deliberations, on the legal aspect of the case, were made by the HR Committee and a consensus was developed to submit an interim compliance to the Honorable High Court of Sindh Hyderabad, if needed, before/on the next date of hearing.
- 5. The Committee discussed to seek legal advice as well from HESCO's legal counsel Mr. Arshad Pathan in this matter being well conversant of the case. It was also suggested that matter, being sensitive, be referred to Nomination and Legal committee of BoD for deliberations to reach a logical conclusion.
- 6. The Committee also showed its concerns on the authenticity of the working strength of Daily Wagers and urged the Management to conduct physical verification from the concerned offices to avoid complications at later stage.
